

BREEDING CENTRE FEES – FROZEN SEMEN COLLECTION

Fees include GST

PLEASE NOTE – Not all stallions semen is suitable for freezing. Approximately 30% of stallions that are collected will not be suitable candidates for freezing and storing of their semen. The only way that we can establish if a stallions semen is suitable and viable once thawed, is to perform the first collection and test freeze and potentially test insemination.

Each collection will vary as to the amount of semen that is given by the stallion, therefore the amount of doses / straws that will be frozen from each collection will most likely vary.

A “dose” for most stallions will be 8 x 0.5ml straws.

If your stallion has not been regularly bred prior to being collected for evaluation, we may need to do several collections over a few days in order to obtain a collection that is of use. These collections will be \$200 per collection, with a maximum fee of \$600.

BOARD / AGISTMENT – STALLIONS

Daily board \$30- per day – includes 2 feeds per day of hay and hard feed.

Stallions in work by negotiation. We are able to exercise stallions on our horse walker if required at an additional cost. *Note* If own feed is supplied, board remains the same price.

FIRST COLLECTION AND TEST FREEZE - \$550.00

This is required to establish which extender is most suited to that particular horse and to evaluate the quality and viability of the sperm once thawed.

FURTHER COLLECTIONS - \$440.00

This fee includes freezing of up to 4 doses from that collection. Each additional dose is \$25.00.

SURPLUS FREEZE – per straw fee of \$12 for semen frozen that was a result of excess collection for AI or chilled shipping. Minimum charge \$200.

PRE-PRINTED STRAWS - \$60.00 per 100 straws

The stallions name, breed and registration number are printed on each straw. We will not use blank straws. Export semen has additional information preprinted.

STORAGE OF FROZEN SEMEN - \$25per month for up to 120 straws, \$0.15 per straw in excess of 120.

A non-refundable deposit is required of \$500.00. The deposit will be deducted from the final invoice.

At this stage we have not applied for export / quarantine status for semen collection and freezing, however it is something that we are planning on in the near future.

EXPORT STALLIONS - Are required to undergo 30 days minimum quarantine prior to being collected for export. During this time, collections may be conducted for domestic use. There will be fees for disease testing etc (veterinary visits and diagnostic testing) as required by the destination country. These fees will be in addition to those listed hereon.

Laboratory testing fees are approximately \$500 plus vet costs.

Export documentation and permit fees are approximately \$3000-

Freight to the destination, freight to quarantine for inspection, return of the shipper, shipper hire, liquid nitrogen and disinfection fees also apply.

A non-refundable deposit is required of \$500.00. The deposit will be deducted from the final invoice.
