Current storage fee is \$25 per month for up to 120 straws or part thereof. \$0.20 per straw thereafter.

Transfer fee of \$55 for each addition to or outward shipment of straws Freight to mare owners is at mare owners expense. Frozen semen owner / agent shall pay EquiNetics \$250 for each service .

TERMS AND CONDITIONS

This agreement is entered into this _____ day of _____, 2024, by and between Jeffrey & Lee Ann Hall of EquiNetics and the Frozen Semen Owner/agent identified above.

The person signing this Contract represents and warrants that he/she/it is the true and lawful owner or agent of the frozen semen, or if not the owner, then has actual authority to act as owner's agent for purposes of entering into this Contract, and to make any and all decisions. The signatory shall be fully responsible for all charges incurred under this Contract and shall indemnify, defend and hold harmless EquiNetics from any and all claims, of every kind and nature, arising as a result of or in connection with this Contract (including any claim that such person lacked the right or authority to execute this Contract on behalf of the true owner). All references in this Contract to the semen owner shall be deemed binding upon the person signing this Contract and the owner of the Semen (hereinafter, individually and collectively referred to as the Semen Owner).



FROZEN SEMEN STORAGE:

1. a. EquiNetics agrees to store frozen semen from said Stallion for use in reproductive procedures and long term storage.

b. Beginning on the date semen arrives storage fees will be applied from that date forward. Billing will occur quarterly for frozen semen storage. When invoices for frozen semen are not paid to EquiNetics through two billing cycles, a notification will be sent to Frozen Semen Owner requesting that frozen semen storage billing is brought current. Frozen Semen will be destroyed 30 days from date of certified letter, whether or not received/accepted by Frozen Semen Owner, if account is not paid in full. EquiNetics reserves the right to adjust prices accordingly as material costs increase or storage procedure changes. Owner will be notified of price increases in writing.

c. Semen Owner agrees to pay all charges associated with shipment of semen to/from EquiNetics. The Semen Owner also agrees to pay any express mail courier/airline shipping charges, courier service charges, and return freight charges. Insurance during shipping must be organized in advance through the shipping entity. EquiNetics does not provide insurance. d. EquiNetics shall make every effort to maintain the frozen semen in proper storage conditions pursuant to this agreement, with proper care, handling and protection according to reasonable standards and practices of the equine industry.

e. The Semen Owner agrees to assume all responsibility for the frozen semen and shall bear all risk of loss or damage to the frozen semen, whether by loss, infection, tank failure, theft or otherwise and by any cause whatsoever, and agrees to hold EquiNetics (or any person employed by or associated with EquiNetics) harmless on any and all damages associated therewith.

2. The Semen Owner agrees to pay all charges in full before removing the frozen semen. At least one-week advance notice must be given prior to shipment of the frozen semen.

3. Frozen semen will not be released if insufficient notice is given or the bill is not paid prior to departure.

4. All invoice balances are payable within 7 days of monthly or final invoice. The Semen Owner agrees to pay all costs and reasonable legal fees incurred by EquiNetics in attempting to collect any outstanding balance. The Semen Owner acknowledges lien rights of EquiNetics and hereby irrevocably grants a lien as described therein to EquiNetics for purposes of securing payment on Semen Owner's account(s). <u>Semen Owner is responsible for any</u> insurance desired on the frozen semen. EquiNetics does not provide insurance.

5. This contract is non-transferable. If the frozen semen is sold, all unpaid fees become immediately due and payable and no refunds will be made.

6. EquiNetics reserves the right to discontinue service at its discretion and to terminate this Contract upon 10 days' advance written notice to Semen Owner.
